

**GUIDELINES FOR APPLYING FOR
ANIMAL FANCIERS PERMIT**

The Ordinance limiting the number of adult dogs to two (2) per household became effective January 15, 1987. A Fanciers Permit is required for owners wishing to have more than two (2) dogs.

The procedure for acquiring a Fanciers Permit is as follows:

- There is no fee for the permit at this time. A nominal fee will be required when a permit has been approved. Fees at the time of issuance are as follows: **Senior (60 or older):** 1 year permit only - \$22; **Under 60:** 1 year - \$122; 2 years -\$153; 3 years - \$184
- A written application must be filed with the City Manager's office.
- After the application has been received, neighbors within 300 feet of the applicant's property will be notified within 10 (10) working days that an application has been filed. They will have ten (10) calendar days to submit written comments, pro or con, to the City Manager. Based on comments received, the City Manager will render a decision within five (5) working days of the end of the comment period.
- There is no limit on the number of dogs for which a permit may be requested.
- Once issued, permits do not need annual renewal. If complaints are received once a permit has been issued, the permit approval is subject to review and reconsideration by the City Manager. Renewal Fees are due upon permit expiration.
