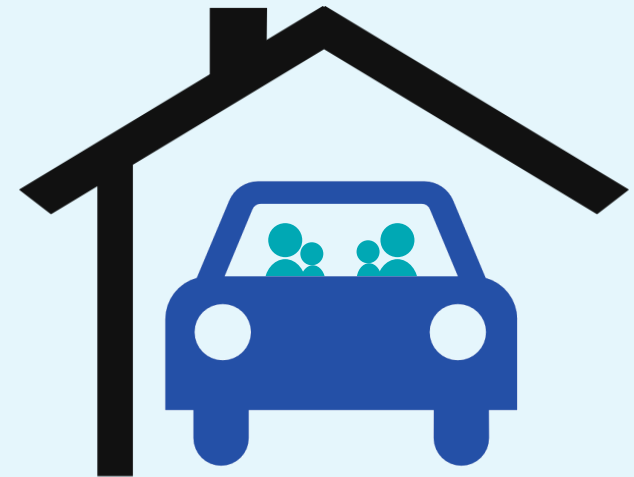

# THE PROGRAM

The CAREavan program is a project organized by the City of Union City, Union City Family Center, local community and faith based organizations in an effort to provide families and/or individuals who have been displaced and are temporarily homeless, living in their vehicles and need a safe place to park and sleep overnight.

All of the participating facilities and locations will provide open restrooms throughout the night. The City of Union City Community and Recreation Services Department will be providing an attendant to be present throughout the night at all of the locations.

**NO** RV's, Motor Homes, or Converted Vans are allowed in the program.

**NO** Trailers are allowed in the program.

Safe overnight parking is permitted at specific locations and days on specific times only. Overnight parking is from 8:00 pm to 7:00 am. Everyone must be out of the parking lot by 7:00 am.

## No exceptions.

You may not park in the parking lots on un-attended nights. Violators will be asked to leave and possibly removed from the program.

## CAREavan Requirements

In order to be eligible and participate in the CAREavan program you meet the following requirements:

- 1 Anyone that is in need of a safe place to park overnight.
- 2 Complete a enrollment form. You must enroll at the Ruggieri Senior Center with Jesus Garcia.
- 3 Must have a running and working vehicle. Vehicles will need to move out of the parking lot at 7:00 am. No vehicle repair work is allowed.
- 4 Must comply with all of the rules and regulations of the program.
- 5 Once registered, you will be given a placard that **MUST** be clearly displayed on your windshield when staying at one of our participating locations at all times.
- 6 **NO** RV's, Motor Homes, Large Vans, or Trailers are allowed in the program.
- 7 Please be respectful of the other participants, our attendants and staff, parking lot and facility. No drugs or alcohol allowed at the parking lots or facilities.

**That's it. It only takes a few minutes to register for the program.**

# RULES AND REGULATIONS

We will be going over all of the rules, standards of behavior and confidentiality notice when you fill out the application.

All rules must be followed. Violation of any rules will result in a review and possibly removal from the program.

## SOME RULES INCLUDE

- Please respect the neighborhood around us. No loud noises and /or music after 10:00 pm. **NO EXCEPTIONS!** Please keep it down.
- Keep the facility, site, and your space clean and free of trash. Please pick up after yourself. **DO NOT LEAVE TRASH OUTSIDE OR ON THE PARKING LOT.**
- Minors and pets must always be supervised by their parents and/or guardians. Attendants are not responsible for your children and/or pets.
- Violent behavior of any kind (Verbal & Physical) towards yourself, family, other participants, and/or CAREavan staff, will not be tolerated. Violation of this rule may result in the immediate expulsion from the program.
- Vehicles must be owner occupied. Only the people mentioned in the application can occupy the vehicle. Outside visitors are not allowed on site and cannot use our facility for any reason. Any unauthorized occupants and or visitors will be asked to leave.
- Placards must be placed in a visible location inside of your vehicle. A current placard is proof that you are registered in the program. If you do not have one, you will be asked to leave.
