Summer Camp Program Preview

Starting Friday, March 26th, Summer Camp Programs will be available for online viewing only. This is your opportunity to review the new protocols, safety guidelines and summer camps that are being offered. Camps will still be modified, however, we will be monitoring CDC and Alameda County guidelines. We hope to be able to incorporate swimming, presenters, or field trips at the appropriate time. Camps will be offered in 2-week sessions this summer starting June 7, 2021 – July 30, 2021. At the time of registration, you are required to pay a \$50 deposit per child, per session fee. This will ensure your child's space in camp. This deposit will be applied to your balance that is due on Tuesday, June 1, 2021. Union City Residents Registration – MONDAY, March 29

Early Bird Camp Registration will be available online starting at 10 am for Union City Residents only. Fees must be paid with a credit card (Visa, MasterCard or Discover). If you do not have computer access or are unable to pay with a credit card, Union City residents can mail in the registration form to the Holly Community Center, 31600 Alvarado Blvd. Union City Ca 94587. Non-Union City Residents Registration – MONDAY, April 5

Early Bird Camp Registration will be available online starting at 10 am for non-Union City Residents. Fees must be paid with a credit card (Visa, MasterCard or Discover). If you do not have computer access or are unable to pay with a credit card, non-Union City residents can mail in the registration form to the Holly Community Center, 31600 Alvarado Blvd. Union City Ca 94587. The form can be found online at www.unioncity.org/192/Community-Recreation-Services under the Program Index labeled **Summer Camp 2021 Registration Form**.

Registration Steps:

1. Go online and verify your family account on the new REC1 registration system PRIOR to MONDAY 3/29. Please make sure all information entered (phone numbers, address, emails etc.) is current and accurate. Verify you are being categorized correctly as a Resident or Non Resident depending on address or school district. If you have questions, need to add children to your account or make other changes, please contact any of the Community Centers during regular business hours. Link: www.Unioncity.org/reg
2. Starting Friday, March 26, all summer camps programs being offered will be viewable online.
3. At the time of registration, you may pay the total amount due, or, pay the \$50 deposit per child, per session (a credit card must be on file for this option). The remaining balance will be automatically charged to the credit card on file on June 1, 2021.

NOTE: Please review all camp information carefully before registering. There is a nonrefundable deposit fee of \$50 per child, per session for any Day Camp transfers or cancellations. All changes must be made in writing at least 1 week (5 working days) prior to the start of each camp's session or all fees will be forfeited. If CRS needs to cancel a session or program, this fee will be refunded or credited back to your REC1 account.
