Written Comment (accepted until the start of the meeting, unless otherwise noted on the meeting agenda)

To provide written comment on an item on the agenda or to address the Commission about an issue during Public Input, you may send an email to communications@unioncity.org. Please include your name and note the agenda item number you want to address or whether you intend for comment to be included in Public Input. Copies of all written comments will be spoken out loud during meeting and will be added to the official record.

Public Comment via Teleconference: Members of the public may address the Commission on a matter on the agenda or during the Public Input portion of the meeting. Raise your virtual hand to notify the host that you would like to speak during that portion. Instructions on Raising your Hand in Zoom Webinar: 1. Click Raise Hand in the webinar controls. The host will be notified that you've raised your hand. 2. If the host allows you to talk, you may be prompted to unmute yourself. While unmuted, your profile picture and name is displayed to the host and panelists. Only your name is displayed to other attendees. 3. Click Raise Hand in the webinar controls to lower it, if needed. This will not mute yourself if you are unmuted. Zoom Shortcuts: x Windows: You can also use the Alt+Y keyboard shortcut to raise or lower your hand. x Mac: You can also use the Option+Y keyboard shortcut to raise or lower your hand.
