\* Please note if you do not have computer access or are unable to pay with a credit card, registration is available in-person at the Holly Community Center, 31600 Alvarado Blvd. between 10 am – 4 pm.

## **Registration Steps:**

1. Go online to [www.Unioncity.org/reg](http://www.Unioncity.org/reg) and create or verify your family account on the CivicREC registration system PRIOR to Wednesday 3/2. Please verify all information in your account (phone numbers, address, residency, emails, emergency information, and t-shirt size) is current and accurate. If you need to add children to your account or make other changes, please contact any of the Community Centers during regular business hours.
2. Starting Friday, February 25, CRS summer camps that are available for early registration will be **viewable online**. Additional Special Interest Camps and half-day camp programs will be available for registration in early spring.
3. At the time of registration, full payment must be made by Visa, Mastercard or Discover, or an online payment plan is available. The online payment plan requires 50% of fees be paid at the time of registration and a credit card saved on file that is valid through August 2022. The remaining balance will be charged automatically to the saved credit card on Wednesday, June 8, 2022.

**NOTE: Please review all camp information carefully before registering.** There is a nonrefundable withdrawal fee of \$25 per child, per session for any Day Camp transfers or cancellations. All changes must be made in writing at least 1 week (5 working days) prior to the start of each camp's session or all fees will be forfeited. If CRS needs to cancel a session or program, this fee will be refunded or credited back to your CivicREC account.
